- 6. All applicable fees as per the DCCERs

FAILURE TO SUBMIT THE REQUESTED ATTACHMENTS (ITEMS 1 - 6) PRIOR TO CONSTRUCTION MAY RESULT IN DENIAL OF YOUR REQUEST FOR IMPROVEMENT. If any change is made without approval, the Committee has the right to tell the homeowner to remove the improvement from his/her property. Any homeowner considering any exterior improvement to his property is urged to review the recorded deed restrictions prior to initial request.
